

Georgia Security and Immigration Compliance Act Federal Work Authorization Contractor Affidavit FREQUENTLY ASKED QUESTIONS AS OF July 28, 2013

- 1. Q: What is another name for the Federal Work Authorization program?
 - A: The program is also known as the E-Verify program as administered by the Department of Homeland Security.
- 2. Q: Which contractors are exempt from the Affidavit requirement?
 - A: Georgia law, O.C.G.A. § 13-10-91, requires all businesses that contract with a public employer for labor or services by bid or by contract in which the labor or services exceed \$2499.99 to sign an affidavit attesting that they are registered for and use E-Verify unless
 - 1) The contractor has **no employees** (in which case the contractor must present an approved state issued identification card/drivers' license from a state which verifies lawful immigration status prior to issuing identification card/drivers' license).

Or

- 2) The contract is with an individual licensed and in good standing under Title 26, Title 43, or the State Bar of Georgia (in which case the contractor must present a statement of exemption based on the appropriate Title). The list of Title 26 and Title 43 exempt contractors is shown below.
- 3. Q: Does MCSD need one affidavit per vendor?
 - A: The affidavits are project-based. MCSD will need a new affidavit for every new contract entered into with the contractor.
- 4. Q: What is E-Verify?
 - A: E-Verify is a federal web-based system that electronically verifies the employment eligibility of newly hired employees.
- 5. Q: Where can a contractor find their E-Verify Number?
 - A; The Human Resources Department of the contractor's business should have the E-Verify number if the company has registered. A contractor can register for E-Verify at the Department of Homeland Security website http://www.dhs.gov/e-verify.
- 6. Q: Is the Federal Tax/Employer Identification Number (EIN) the same as the E-Verify Number?
 - A: No.
