Subject Approve the Contract Award to Southeastern Paper Group, for the Purchase of Paper Products and Supplies

Type Action

Background and Rationale: A competitive solicitation process was completed for the School Nutrition Program for the purchase and direct delivery of paper products and supplies to all schools of the Muscogee County School District. Invitation to Bid #24-017 was emailed to thirty-two vendors and posted to the Muscogee County School District (MCSD) website and the Georgia Procurement Registry website on March 22, 2024. The Purchasing Department received proposals from five vendors:

- 11400, Inc.
- Devi Enterprises LLC (dba) Head to Heels Safety Supplies
- Imperial Dade (formerly COPACO, Inc.)
- Nottage, LLC
- Southeastern Paper Group

A vendor contact summary is shown below and a bid summary is attached.

The Board is asked to approve the contract award to Southeastern Paper Group for the purchase of paper products and supplies. The contract is awarded to the vendor offering the highest quantity of items at the lowest delivered prices. The contract term is for one-year effective July 1, 2024 through June 30, 2025, with the option to renew for two additional years.
