Subject Approve the Bid Award to Outdoor Solutions for Grounds Maintenance Services

Type Action

**Background and Rationale:** A competitive solicitation process was completed for grounds maintenance services for District-wide school buildings, Muscogee County Public Education Center (MCPEC), Columbus Public Library, three library branch buildings, and associated support buildings. Invitation to Bid #24-012 was emailed to forty-one vendors and posted to the Muscogee County School District (MCSD) website and the Georgia Procurement Registry website on November 28, 2023. A mandatory pre-bid meeting was held on December 13, 2023. The Purchasing Department received proposals from eight vendors:

- Absolute Quality Services, LLC
- Dreamscapes Designs, LLC
- Four Seasons Lawn Care
- Landscape Workshop, LLC
- LaGrange Landscape (Disqualified-Received Late)
- Outdoor Solutions
- Rotolo Consultants
- Worldscapes, LLC

A vendor contact summary is shown below and a bid summary is attached.

This bid process included multiple criteria to ensure the District receives the most cost-efficient solutions, maximum performance levels, and first-rate service at all locations. The specifications allowed the vendors to bid on each area based on regions (west, central, and east), athletic fields only, non-athletic areas, and the entire project (which includes the athletic fields). After a careful review of all the bids received, it was determined that awarding the contract based on the "entire project" criteria represents the most cost-efficient solution for the District at this time. This criteria includes all school buildings, athletic areas, the MCPEC building, Columbus Public Library (including Mildred Terry Public Library, North Columbus Public Library, and South Columbus Public Library), and all associated support buildings. Outdoor Solutions offered the lowest price for the entire project. The Board is asked to approve the bid award to Outdoor Solutions for grounds maintenance services as highlighted on the bid summary for the period March 1, 2024 through February 28, 2025. An additional total amount of \$60,000 for Fiscal Years 2024 and 2025 has been added to the budgetary impact for incidentals such as sprinkler system repairs, additional flower bed work, the addition of pine straw, etc.
